While the IAQ proposed rule was withdrawn in its entirety in December 2001 (66 FR 64946), the Agency retained the voluminous docket (consisting of approximately 120,000 documents), which contains valuable information on ETS and other indoor pollutants, such as chemicals, bacteria, and molds. In preparing this guide OSHA has reviewed the IAQ docket and recent scientific literature pertaining to mold exposures. As a result of this review, it is clear that the entrance of
