web most taxpayers no longer have the option to carryback a net operating loss nol for most taxpayers nols arising in tax years ending after 2020 can only be carried forward the 2 year carryback rule in effect before 2018 generally does not apply to nols arising in tax years ending after december 31 2017 web oct 4 2022 a corporation s net operating loss nol is equal to the
